THE ASSOCIATION

Established in 1986 by a small group of visionaries the Association has come a long way since its inception. The founding members were mostly family owned businesses and their growth and expansion has been limited and constrained by their limited access to the resources required to grow their businesses rapidly both in terms of finances and human capital. This has greatly limited the ability to expand their agricultural production base to ensure consistent supplies of quality produce at competitive prices. This also applies to those in the processing sector.

In the recent past we have seen a growing interest and entry of larger corporates into the Agri-food sector and their greater participation in the activities of the association will continue to add strength to its activities. There is no question that there is much work to be done to realize the full potential of agricultural exports from this country and the main focus of your association's activities is to expand the production of quality fruit and vegetables to realize our goal of making this sector a significant contributor to national export revenues.

OBJECTIVES

The Association has created a platform for its membership to interact with each other, to disseminate information which will improve the industry and represent its members in all public fora with particular emphasis on ensuring the continued development of the Fruit & Vegetable Industry through the following activities:

Review of Association Activities – 2021/2022

The year was a tumultuous and calamitous one for the country for reasons that are well known to all of you. This resulted in the industry facing severe challenges and it is heartening to note that all of us have come through unscathed in spite of the many difficulties and challenges that were faced in keeping our day to day operations alive. Unfortunately, the Global Outlook does not look very promising either and there is no question that our resilience will continue to be tested in the years ahead.

Notwithstanding the above your Board and the sub committees continue to work tirelessly towards the goals and objectives we have set out for ourselves over the foreseeable future. Particular mention must be made of the Mango Cluster Subcommittee that has made significant progress in spite of the challenges faced. I am pleased to report that we have made positive progress towards securing the required funding to start on a program to increase the availability of export quality Mangoes that will drive our export revenues. It is hoped that we will have embarked on this program as we meet today for our AGM. No sooner implementation of this program is effectively on its way it is intended to replicate this model for Pineapple and Banana Cultivation and gradually expand our activities to cover other crops.

The Processing Subcommittee whilst slow of the blocks is gaining traction and I have every confidence that using their individual strengths and expertise we will see some equally promising and significant progress under their stewardship.

We have discussed many other plans such as the development of ICT and the undertaking of Joint Promotions under the flag of Association. However, the response received from the general membership has been disappointing. Efforts have been made to include and involve as many members as possible to ensure the activities of the Association are beneficial to all its members. This is a two-way process and unless individual members make the effort the benefits of the activities of the Association will not accrue as widely as we would like it to. It is however pleasing to note that more Corporates are entering the Agri- Food Business and more of them are joining the Association. With their strength and involvement, we are confident that it will only lead to a significant growth in export revenues from our sector and make it a significant contributor to the Country's GDP.

I would like to thank all of you who continue to actively support and participate in the activities of the Association and look forward to continuing to this association in the years ahead. I wish to thank the representative of the EDB Thilini Upadya who was a member of our Board over the past so many years and resigned to take up a posting overseas. I also wish to thank Ushani and her assistant who have continued to work tirelessly on behalf of us all. Mr. Gnanaskandan who has held the reins as the de facto treasurer of the Association for many years now for his continued efforts. He is seeking to hand over these responsibilities and it is hoped that we will be find a suitable replacement in the coming year from amongst our members to take on this role.

The Association (LFVPPEA) continues to engage with Government Ministries, Statutory Authorities & Departments and relevant stakeholders in influencing policy as well as representing and resolving operational issues face by its members. During the year we interacted with many multilateral agencies undertaking projects in the agri food sector and I am happy to report that we are making progress in this regard.

Visit of Jordanian NPQS Team

A team of Inspectors from the Jordanian Quarantine Services visited Sri Lanka in order to assess the country's capability to satisfactorily meet the SPS requirements for the export of fresh mango and pineapples to Jordan. This visit was arranged by the NPQS in conjunction with our Association. The visit was concluded successfully with the Jordanian NPQS lifting the ban on exports of Mango and Pineapple from Sri Lanka to Jordan.

Meeting with KOICA Delegates

A meeting was held with a delegation from KOICA on 11 February 2022. During the discussion it became clear that the objectives of their visit varied from those of the Association and it was decided not to pursue this matter further.

Fuel Crisis

The Association supported its members to purchase fuel during the height of the crisis through the good offices of Mr. Zuraish Hashim, whilst Nelna Agri Business provided storage facilities and Mr. Marikar coordinated the fuel requirements amongst the members. This is a good example of how teamwork can help to bring benefits to the members of the Association and I wish to express thanks on behalf of all of us to the above mentioned people who made this possible.

NPQS – Seed Imports

Representation was made with regard to sampling, testing and certification of seed import issues faced by some importers. This continues to be work in progress.

Projects

- a. Noberasco. - On account of both local and global challenges little progress was seen in this relationship.
- b. Regenerative Agriculture Solutions –**
Dole Lanka (Pvt) Ltd arranged for an introduction to TriPoint and a presentation was made by Dr. John Hedlund (MD) and Dr. Elaine Ingham on Regenerative Agriculture. Following this presentation, the association was requested to take the lead role in engaging with TriPoint and facilitating their entry into Sri Lanka with their revolutionary agricultural technology. I am pleased to report that considerable progress has been made with the TriPoint team and it is expected that they will setup operations in Sri Lanka in the coming year.
- c. FAO Fruit Value Chain Development – a five-day online program titled “Capacity Building Activity on Tropical Fruit Production Technology and Industry Development under China FAO-Sri Lanka South -South Cooperation Project” was conducted from 10th to 14th October 2022.

- d. Developing food loss reduction pathways through smart business practices in mango and tomato value chains in Pakistan and Sri Lanka. The project inception workshop was conducted at the Institute of Policy Studies on Wednesday the 05th October 2022 in which the association made a presentation of its planned activities.
- e. USAID Climate Adaptation Project

USAID Climate Adaptation Project stakeholder consultation workshop on the Agriculture sector held virtually on 01st September 2022. The purpose of this national level stakeholder consultation is to validate the findings of the Climate Risk Assessment (CRA) conducted by the USAID Sri Lanka Climate Adaptation Project, in collaboration with private and public sector representatives from the three priority sectors of agriculture (which for the purpose of this project includes livestock and plantations), fisheries (this includes coastal and inland fisheries, and aquaculture) and tourism.
- f. PwC supported the launch of the Sustainable Development Goals (SDGs) by working with the United Nations Global Compact, the World Business Council for Sustainable Development and the Global Reporting Initiative to understand how ready businesses were to support the SDGs. The link to participate in this workshop was shared amongst the members.

Seminars/Interactive forum

No activates took place in the current year.
